HF-NCNE-POLICY-0001-2019/3783/HE, Dated, Bhubaneswar, the 24th January, 2020

In exercise of powers conferred under proviso to Sub-Section (6) of Section-7 of the Odisha Education Act, 1969, pending reconstitution of the Governing Bodies or the Managing Committees, Government after careful consideration have been pleased to dissolve the Governing Bodies or Managing Committees of all Non-Government Aided Degree Colleges of Odisha coming under the purview of Higher Education Department with immediate effect except the Autonomous Colleges and the colleges established by Minority Communities.

Where the college is situated at the district headquarters, the Additional District Magistrate of the concerned district shall act as President of the Governing Body or the Managing Committee till further order. In case of any district having more than one Additional District Magistrate, the District Magistrate and Collector shall nominate one Additional District Magistrate to act as President of the Governing Body or the Managing Committee.

Where the college is situated outside district headquarters, the Sub-Collector of the sub-division concerned shall act as President of the Governing Body or the Managing Committee till further order.

This notification shall come into force immediately with effect from 24th January, 2020.




